Role of Syariah Adviser

In ensuring Syariah compliance in the Islamic finance industry, Brunei Darussalam practices a two-tier Syariah governance framework.

At the national level, the Syariah Financial Supervisory Board was established pursuant to the Syariah Financial Supervisory Board Order, 2006. The Board is responsible for ascertaining Hukum Syara' for Islamic Financial Institutions (IFIs) supervised by Brunei Darussalam Central Bank (BDCB).

Whereas, at the industry level, existing legislations require IFIs to establish a Syariah Advisory Body (SAB). The SAB is responsible for ensuring the IFI's operations are in accordance to Hukum Syara'.

Following that, BDCB has issued the Notice on Appointment of SAB and Guidelines on Fitness and Propriety of SAB, which outlines the appointment process and criteria that an individual shall possess to be appointed as SAB.

It is aspired that the SABs are to progressively adapt to the ongoing market developments and current trends in order to ensure that Syariah Compliance is firmly upheld while providing innovative Syariah solutions to the Islamic Financial Industry.


